Tot Trade Charlotte Consignor Agreement – Spring/Summer 2012 Event

Please read carefully:

In order to file a discrepancy at the end of the sale consignors must follow the discrepancy guidelines outlined on the Tot Trade Charlotte website:

*Consignors must mark each item with masking tape and use card stock paper.

*Discrepancies must be filed within 24 hours of pick up, Tuesday, February 28 @ 630PM. Requests filed after this date and time cannot be researched.

In consideration for the ability to participate in and earn profits from the Tot Trade Charlotte Spring 2012 children's seasonal consignment event (herein "Event"), the undersigned Consignor agrees to the following terms and conditions:

*Consignor agrees that Tot Trade Charlotte is authorized to sell all items dropped off at the event.

*Tot Trade Charlotte reserves the right to reject or pull from the sales floor any item failing to meet its standards or which is deemed inappropriate by the staff of Tot Trade Charlotte;

*Consignor shall earn 65% of Consignor's total sales; Tot Trade Charlotte shall earn 35% of Consignor's total sales;

*Consignor acknowledges that Tot Trade Charlotte will not honor handwritten changes or scratch through on tags. All items will be sold for the original value marked on the tags. If the original value is unable to be determined by a visual inspection of the tag, Tot Trade Charlotte reserves the right to pull the item from the sales floor;

*Consignor acknowledges that all paid registration fees are nonrefundable;

*Consignor herein warrants that Consignor is the owner of the items to be sold and has authority to sell said items; that each item is in good operating condition, normal wear and tear excepted, and is not defective, broken, or damaged in any way; that any repairs made to an item have been made in accordance with the original manufacturer's warranty program; that each item complies with applicable laws; and that no item presented for sale is the subject of any pending or threatened recall notice or consumer protection action and that the consignor has checked each item on the website referenced in the Tot Trade Charlotte material www.cpsc.gov to confirm that items are in compliance.

*Consignor acknowledges that Tot Trade Charlotte has the right to price an item if it is found without a price.

*An unclaimed items will be donated to charity;

* Consignor acknowledges that Tot Trade Charlotte provides for pick up of any unsold items on Monday, February 27 from 4-6:30PMPM. All items not picked up by 6:30PM on Monday shall be donated to charity that same day. Tot Trade Charlotte cannot hold items beyond this allotted time slot;

*Consignor herein covenants and agrees to indemnify, defend and hold harmless Tot Trade Charlotte, its owners, volunteers or participants, from and against all claims, costs and expenses resulting from any claim, demand or cause of action arising from any injury to any person or damage to property, occurring as a result of participation in the sale.

Consignor herein agrees to hold harmless Tot Trade Charlotte, its owners or volunteers, for any damage, theft or loss of any items to be consigned.
